AP Released Free Response Prompts Aligned to the Common Core State Standards for Reading: Literature

Note: If you look closely at the AP requirements set forth in most rubrics, including the "Rubric of all Rubrics," which can be found at http://mseffie.com/AP/Rubrics.pdf, you will notice that, even though the prompt may not specifically state it, AP expects students to provide specific evidence (RL.1) from the piece of literature to support analysis as well as a connection of the analysis to the meaning of the work as a whole (RL.2). However, I only included these standards in the alignment if it was explicitly stated in the prompt. These prompts also align with many of the writing standards.
